**SHORT TENDER DOCUMENT**

Sealed bids are invited from interested and competent firms for "GPS device supply, installation/ repairing, and connectivity for ASTC vehicles under ONGC operation" at Assam State Transport Corporation, Sivasagar, Jorhat, and Silchar fulfilling the following terms and conditions.

**Terms and Conditions:**

1. The bidder must ensure that their product (GPS device) is compatible with ONGC system specifications. The GPS device must be compatible with the software listed at <http://www.traccar.org>. The software being used is Traccar Open source software. ONGC server for the Centralised Vehicle Tracking System with VTS Software (Traccar) is installed at ONGC, Delhi for tracking all ONGC vehicles (Owned/ Hired).
2. The selected bidder has to ensure whether the GPS devices already installed in ASTC vehicles are in working condition or not. If those devices are repairable, they are to provide a estimate for the same and shall be decided on it by ASTC later on.
3. The selected bidder must ensure that the user application software connected to GPS device must be accessible by both ASTC and ONGC officials.
4. The selected bidder has to supply, install/ repair, and provide connectivity as per ONGC software to operating state for ASTC vehicles running under ONGC which should be accessible by both ONGC and ASTC.
5. The bidder has to submit Earnest Money Deposit (Refundable) – Rs. 50,000/-, Demand draft in favour of Managing Director, Assam State Transport Corporation, Payable at SBI, South Guwahati Branch.
6. The bidder has to provide warranty for the product of minimum three (3) years from the date of supply. Further, the bidder will provide maintenance support including cellular connectivity support for a period of three (3) years from the date of supply which may be extended later on.
7. After opening and evaluation of bids, the accepted bidders must provide product demonstration to ONGC and ASTC officials as and when requested for. The final selection will depend upon satisfactory response of the product from ONGC and ASTC officials. The date of demo will be informed later on.
8. The payment will be done after successful supply, installation, commissioning of the product, and connectivity as per ONGC software to operating state and after due certification of the same by ASTC and ONGC officials at Sivasagar.
9. Any new information related to this short tender will be provided in ASTC website <https://astc.assam.gov.in/> only.
10. The rates are to be quoted per unit (supply, installation/ repairing, and connectivity) inclusive of all taxes and charges.
11. The yearly maintenance cost for cellular connectivity charges will have to be quoted separately on yearly basis, which may vary depending on the plan of network provider.
12. The vehicles operating under ONGC are present in Sivasagar, Jorhat, Silchar.
13. The GST number of the firm must be provided along with GST certificate.
14. The document for originality of the product must be provided by the bidder.
