


Terms and Conditions for Allotment of Bus branding business on AC (Jan) Bus, Non AC (Ultra) buses and RCV (Rural Connectivity) Buses Of ASTC.

1. The quotationers are to be quoted on rate for each buses are fixed . Minimum Rates for Bus Branding are as follows :
 - 1) AC (Jan) Buses : Rs 54,380.00 per bus per year
 - 2) Non AC (Ultra) Buses : Rs 26401.00 per bus per year.
 - 3) RCV buses: Rs 19,800 .00 per bus per year.
2. Quotation documents may be collected from the office of the undersigned during office hours of all working days up to 2.00 pm from 13/10/2020 to 19/10/2020 at the cost of Rs 500.00 (Rupees five hundred)only by depositing Bank Draft of any Schedule bank duly pledged to the Managing Director ASTC, Paltanbazar which is non-refundable. The date of receiving Quotation is 20/10/2020 up to 2.00 pm and will open the quotation on the same date in presence of the Quotationer or their authorised representative. **The quotation has to be submitted in sealed envelope with along with all relevant documents.** Quotationers should mention "Quotation for allotment of Type of bus and Quoted rate clearly".
3. The term for allotment will be 1 (one) year which may be renewed @ 10% enhanced rate on mutual acceptance of ASTC authority and the party.
4. The quotationers will have to deposit an Earnest money of **Rs 10,000.00(Rupees ten thousand) only**, for each along with the quotation in the shape of Bank draft in any scheduled bank payable at Guwahati in favour of Managing Director, ASTC Guwahati . **Earnest Money is refundable.**
5. All Payment has to be done in one-time only and payments are accepted through Bank Drafts only.
6. No other mode of payments are accepted. After receipt of total payment we will issue necessary order.
7. Work experience in field of branding for the last 5 years has to be provided with supporting documents
8. The agency should have minimum average turnover of Rs 2 crore in the last 3 financial year (2017-2018, 2018-2019,2019-2020).
9. Following parties who are not eligible for participating in the RFQ:
 - Debarred/back listed by CBI or ASTC or undertaking/Departments of Central Government or State Government.
 - Parties facing action under any act and court case pending in the courts and also pending in court cases with ASTC.
 - Parties either an individual or a business establishment, who has not paid outstanding dues to ASTC , in connection with any type of business carrying under ASTC shall not be eligible for the quotation. A declaration to this effect has to be submitted on Non-Judicial Stamp paper of Rs 20.00 (Rupees twenty) only duly attested by the Notary public by the party while submitting the Quotation. Either the party may clear all the dues to ASTC and then eligible for the quotation and must be supported the dues clearing documents..

10. An amount of Rs 1000.00 (Rupees one thousand) only per bus has to deposited as Security money, which is refundable after expiry of the term. Security deposit will be returned only after concerned D/S's report of receipt of buses in good condition. This will be effected after award of LOI/ allotment order by the authority.
11. No damages/distortion can be done to the body of the Buses.
12. An undertaking is to be given during the time of possession to the concerned Divisional Superintendent of ASTC.
13. After completion of the allotment period, the party will be responsible for removal of the branding sheets without any damage to the Bus and Handover it to D/S in its original conditions
14. If during the term of allotment, the branding sheets gets damaged or gets torn by any miscreants, the authority cannot be held responsible for refund for it and cannot claim any refund of money/loss etc.
15. Other relevant terms & conditions will be incorporated in the Allotment order.
16. An agreement will have to be executed in between the ASTC and the licensee for which a non-judicial stamp paper of Rs. 50.00 (Rupees fifty) only to be submitted for execution.
17. The undersigned does not bind himself to accept the highest quoted quotation and reserves the right to reject any or all quotations without assigning any reason thereof.
