## CIRCULAR

Dated, Guwahati the 28th July,2022.

Whereas the report of Works Manager, Central Workshop Rupnagar received letter No. ASTC/WM/Rup/Camp dev/22-23/1053 dated,21-07-2022 wherein it is stated that due to security measures restrictions have been imposed vide their office circular No.513-A dated,30-10-2021 and 518 dated 1-11-2021 also in the report it was stated that 18 Nos. shutdown buses were caught in fire at the midnight of 08-02-2017 and at times unknown persons in disguise creates unpleasant situation inside the campus.

Further, the complex having some major infrastructure like Central Workshop, Central Store, Divisional Workshop (City Service), EV Charging Station, H.S.D. Consumer Pump, Maintenance Centre and office of the Works Manager, CWS, Divisional Superintendent, GGRCS including 2 (Two)Nos. of City Bus Depot and also there are numbers of ASTC fleet both runner and shutdown are parked as well as unserviceable/junk materials are also stored.

In view of the above report received from the Works Manager, ASTC CWS Rupnagar and in pursuance of earlier order issued from time to time by the Works Manager and for the safety and security reason, the entire complex is declared as Restricted Area and entry of outsiders without prior approval from the concerned authority is strictly prohibited.

Any violation, of this order will be viewed seriously and it will attract appropriate action against the officials responsible for the violation.

This order shall come into force with immediate effect and remain in force until further order.
