Whereas complaint received through social media lodged by Shri Subhrajit Roy, bonofide passenger regarding denial on acceptance of the Chalo Bus Card by an conductor of ASTC Bus No.AS-20/1913 while travelling from Kachari to Paltanbazar on 26<sup>th</sup> August,2022 and fare was realised by the conductor without issuing ticket in the City bus and whereas report called from the concerned Divisional Supdt., wherein he stated that it's a free service dedicated for the Students and Staff of Gauhati University in which no other passengers are allowed to travel. Further, there is no ticketing machine was provided to the Conductor as the bus Service was dedicated for Students & Staff of Gauhati University only. However, the crews of the said dedicated service vehicle picked up other passengers and realised fare by violating the rules and procedure of the Corporation for personal interest of both the crews.

In view of the above, pending drawal of departmental proceeding, Shri Utpal Talukdar, Driver (F-11) and Shri Rubul Hazarika, Conductor (F-228) of the vehicle No.AS-20/1913 ASTC City Service Rupnagar Depot are hereby placed under suspension with immediate effect.

During the period of suspension, Shri Utpal Talukdar, Driver and Shri Rubul Hazarika, Conductor ASTC City Service Rupnagar Depot will not be entitled for any pay and allowances except subsistence allowance.

This order shall come in to force with immediate effect.
