Sealed quotations affixing court fee stamp of Rs 8.25 only are invited from reputed and experienced company/firm involved in supply, installation of access points (A.P) and other peripherals annual maintenance of machines for launching "<u>Wi-Fi SYSTEM</u>" in the Divisional/ Station Superintendent's offices of the Assam State Transport Corporation (ASTC). These include the Corporation's Divisional/ Station Superintendent's Offices of all the Districts of Assam including in phased manner.

The company/ firm shall have to assess and prepare "Office wise Cost Based Quotation" inclusive of GST showing item wise break up of rates such as (i) Cost of Wireless Router machine with name of brand and Capacity (ii) Cost of LAN Cable per meter (iii) Cost of Electrical Fittings (iv) Cost of Rack (iv) Installation Charges for the office as a whole. The quotation paper should also specify the guarantee/ warranty period, conditions of replacement of brand wise machines, and Annual Maintenance Charges separately along with each quotation for each office.

 - (vii) Experience Certificate of supply to Government/STU/ASTC if any.
