TERMS AND CONDITIONS FOR SUPPLY OF NEW AUTOMATIC NITROGEN TYRE INFLATOR, AIR COMPRESSOR AND BUS TYRE CHANGER

- 1. The rate should be quoted as Freight on Road (F.O.R) Destination as specified in the tender document. It will be the responsibility of selected bidder to supply and install the required equipment at the site as per ASTC requirement at no extra cost beyond the financial quote enclosed in commercial bid. ASTC official/s shall issue a go-live certificate after successful commissioning of the equipment. Payment for equipment shall be released only after successful commissioning.
- 2. Bidder shall be an Original Equipment Manufacturer (OEM)/Authorized Dealer of an OEM having at least 3 years experience in supply, installation and commissioning of Automatic Nitrogen Tyre Inflator, Air Compressor and Bus Tyre Changer in the current period.
- 3. Manufacturer of the equipment must have ISO 9001:2008 or equivalent certification for design, manufacture and marketing of Automatic Nitrogen Tyre Inflator, Air Compressor and Bus Tyre Changer in the current period.
- 4. The GST rates, if any, whether inclusive or not, must be clearly stated in percentage and calculated in amount as part of the financial bid.

 - b. Payment of 10% Value of Work Order: Remaining 10% payment shall be released after the expiry of warranty period.
- 15. **Inspection of Goods**:-The ordered item/s will be inspected by ASTC officers at the time of delivery. The supplier should inform the date of delivery.
- 16. If any manufacturing defect is found, the defective equipment shall have to be replaced by the supplier free of cost.
- 17. If any damages of any item/s occur in transit, then that shall be replaced by the supplier at their own cost.
- 18. **Testing for Quality:** Bidder should provide a certificate of quality assurance from NABL/BIS accredited labs at the time of delivery of the goods. The certificate should clearly mention the type of item with serial number.

 - b) If the supplier fails to follow the terms & conditions and instructions as mentioned in the tender document or conditions mentioned in purchase orders.
 - c) If the supplier is found defaulter.

- 23. The Corporation reserves the right to place an order to any party who is ready for supply at the accepted rate for the items cancelled. The Corporation reserves the right to place an order on 2nd lowest rate if any supplier is not ready to supply on 1st lowest rate for items whose order is cancelled (which was placed on 1st lowest rate but party failed to supply).
