

Tender will be received in the office of the Managing Director on or before 18.05.2018 upto 1.00 pm and will be opened at 3.00 pm on 18.05.2018 .The interested tenderer(s) or their authorized representatives may remain present at the time of opening the tenders. The intending bidders may inspect the unserviceable used tyres, on permission of the office/officers concerned, on any working day during office hours and quote the rates per tyre (both in figures and in words) against each lot . No open tender will be accepted. The rate so quoted in the tender(s) both in figures and words should not be over written.The rates should be quoted in INR only. Tenderer may also send their tenders by registered post in the name of Managing Director, ASTC, Paltanbazar, Guwahati-781008, which must reach the undersigned on or before 1.00 pm of 18.05.2018.The corporation will not be responsible for any delay in delivery of the tenders by the postal authority or missing of the same in transit.

The individual number of tyres may be seen/inspected in the concerned office during the office hours on all working days by contacting the ASTC's in charge officer(i/c) of the location/station/workshop.

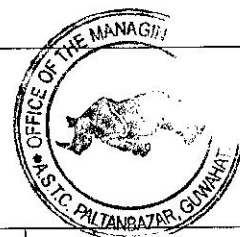

The tenderer will have to furnish earnest money, only per lot as mentioned above by demand draft payable at State Bank of India, South Guwahati Branch, Guwahati-781007 or any Nationalised bank drawn in favour of the Managing Director ASTC, Guwahati along with the tender(s). The Earnest Money of those tender(s) who are not successful will be refunded after the tender process is over.

The successful tenderer (s) will be intimated after acceptance of the tender(s) and full amount will have to be deposited by the concerned tenderer to this office within 10 (ten) days time from the date of intimation of such acceptance.

A photocopy of tender document with signature of the bidder in each page shall have to be submitted along with the tender. Tender shall have to be submitted in the prescribed format and sealed tenders shall have to be dropped in the drop box placed at H.O, ASTC, Paltanbazar, Guwahati-8 before due date.


The unserviceable items will have to be lifted within 10 (ten) days time from the date of issue of lifting order against payment of full value, after which period, the unserviceable tyres will remain absolutely at the risk of successful tenderer(s) and will be liable to pay ground rent @ Rs 100/- (one hundred rupees) only per lot per day upto 10(ten) days only beyond the allowable time limit. If successful tenders(s) fail to remove the unserviceable tyres within the maximum limit of (10+10) = 20 days time, the successful tenderer (s) will have no claim over the unserviceable tyres as deemed fit even without initiating the said successful tender(s)



If the successful tenderer(s) refuse to or fail to deposit the full value of the amount of accepted tender(s) within stipulated time, the earnest money furnished by him/them will be forfeited to the corporation besides recovering the cost that is sustained by the corporation in disposing of the stock to any other party from the amount lying with the corporation or any other account or at the risk of the original tender.

The Managing director, ASTC, reserved the right to settle the sale individually or by lot. The Managing Director reserves the right to reject any or all tender(s) and withdraw from sale any portion or lot without assigning any reason thereof. Document fee is non refundable. E.M. interest free.
