ASTC invites tender in sealed cover super-scribed with the words "TENDER FOR PURCHASE OF BURNT LUBE OIL" lying at places mentioned below, from interested party/individual which will be disposed of in "AS IS WHERE IS" condition.

Tender will be received in the office of the Managing Director on or before 25.9.18 upto 1 p.m. and will be opened at 2.30 p.m. on 25.9.18. The interested tenderer(s) or their authorized representatives may remain present at the time of opening the tenders. The intending bidders may inspect the burnt lube oil, on permission of the office/officers concerned, on any working day during office hours and quote the rates per barrel/drum(both in figures and in words)against each lot. No unsealed tender will be taken into consideration. The rate so quoted in the tender(s) both in figures and words should not be over written. Tenderer(s) may also send their tenders by registered post in the name of Managing Director, ASTC, Paltanbazar, Guwahati-781008, which must reach the undersigned on or before 1.00 pm of 25.9.18. The corporation will not be responsible for any delay in delivery of the tenders by the postal authority or missing of the same in transit.

The burnt lube oilmay be seen/inspected in the concerned offices during the office hours on all working days by contacting the ASTC's in charge officer(i/c) of the location/station/workshop.

Interested tenderer(s) will have to obtain detailed tender papers from the office of the Managing Director, ASTC, Paltanbazar, Guwahati-781008, on payment of tender fees Rs 500.00 (five hundred) only in cash during office hours upto 4 P.M. Tender without payment of fee will not be accepted. The tender document fees is non refundable.

In case tender document is downloaded from our website, the document fees of Rs.500/- shall have to be submitted along with the tender in the form of DD to be drawn in favour of Managing Director, ASTC

The interested tenderer(s) will have to submit the tender document along with tender document tees. DD in prescribed format and sealed tenders shall have to be dropped in the tender box placed at H. ASTC, Paltanbazar, Guwahati-781008 before due date.

The tenderer(s) willpower have to furnish the earnest money, only per item as mentioned above by demand draft payable at State Bank Of India, South Guwahati Branch, Guwahati-781007 or any Nationalised bank drawn in favour of the Managing Director, ASTC, Guwahati along with the tender(s). The Earnest Money of those tenderer(s) who are not successful will be refunded without interest after the tender process is completed.

The successful tenderer(s) will be intimated after acceptance of the tender(s) and full amount have to be deposited by the concerned tenderer to this office within 10 (ten) days time from the date of intimation of such acceptance.

A photocopy of tender document with signature of the bidder in each page shall have to be submitted along with the tender.

The lube oil items will have to be lifted within 10 (ten) days time from the date of issue of lifting order against payment of full value, after which period, the items will remain absolutely at the risk of successful tenderer(s) and will be liable to pay ground rent @ Rs 100/-(one hundred) only per item per day upto 10(ten) days beyond the allowable time limit. If successful tenderer(s) fail to remove the Items within the maximum limit of (10+10) =20 days time, the successful tenderer(s) will have no claim over the items as deemed fit even without intimating the said successful tender(s).

If the successful tenderer(s) refuse to or fail to deposit the full value of the amount of accepted tender(s) within stipulated time, the earnest money furnished by him/them will be forfeited to the corporation besides recovering the cost that is sustained by the corporation in disposing of the stock to any other party from the amount lying with the corporation or any other account or at the risk of the original tender.
