No unsealed tender will be taken into consideration. The rate so quoted in the tender(s) both in figures and words should not be over written. 
A photocopy of tender document with signature of the bidder in each page shall have to be submitted along with the tender.

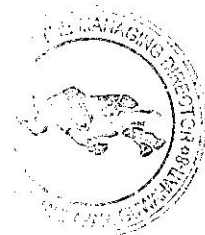

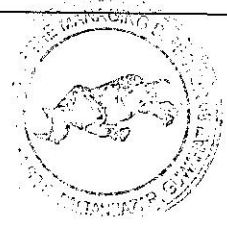

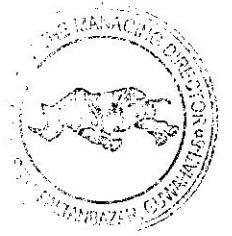
