SPECIFICATION OF THE TICKET


- 1 The sample of the ticket may be inspected in the Stationery office of the Head Office , A.S.T.C. Guwahati during office hours.
- 2 No. of tickets in a book will be 100 pages in duplicate.
- 3 Paper must be with ground printing "UNDER "ASSAM STATE TRANSPORT CORPORATION" by black ink for original page and red ink for duplicate pages.
- 4 Serial No. of the tickets starting from 000001 to 1000000 for every series.
- 5 Book must be bounded with brown cover paper and book serial No.
- 6 The quality of the paper must be 7.4 K.G.(White) Superior quality.
- 7 The size of the ticket book 17c.m x 8.5 c.m.
- 8 Note on the back side of the duplicate copy of ticket must be inscribed as below.....

NOTE : FOR ATTENTION OF PASSENGER CANCELLATION CHARGE

- a 10% of total fare up to 4 hours ahead of departure
 - b 50% of total fare up to 1 to 4 hours ahead of departure
 - c 10% of fare will be charge extra if the tickets is issued by an agent.
- 9 The logo in A.S.T.C. in light colour must be printed on the main tickets with ground printing.

TERMS AND CONDITIONS

- 1 The tender must be in closed sealed cover " QUOTATION FOR P.O.B. WAYSIDE TICKET" must be inscribed on the cover and name of the party.
- 2 Earnest money of Rs. 20,000/- (Rupees- Twenty Thousand) only in the form of Demand Draft pledging in favour of the Managing Director, A.S.T.C. payable at Guwahati must be enclosed with the tender. Without E/M, the tender will not be considered for acceptance.
- 3 Income Tax and Sales Tax clearing certificate must be enclosing with the tender.
- 4 TIN No. or GRN No. of the firm must be enclosed with the tender.
- 5 Documentary evidence of post performance must be enclosed with the tender.
- 6 Receipt of the tender will be closed at 2.00 P.M. on 10-05-2018. No tender will be accepted after the closing date and time.
- 7 Licence No. and Registration No. of the firm must be enclosed with the tender, else the tender will not be considered.
- 8 Paper sample must be enclosed with the tender.
- 9 Earnest Money of the un-successful tenderer will be refund after finalisation of the work of allotment.
- 10 Successful tenders will be intimated after acceptance of their tender and job allotment order will be issued. The Earnest Money of the successful tenderer will be converted into Security Deposit. The Earnest Money will be forfeited if any tender fails to carry out the work after allotment of printing order.
