- 1. The tenderer should submit tenders in sealed envelope super scribing the NIT No. ASTC/HO/Purchase/Tender/AC AMC/2022-23/9817 Dtd. 06.06.2022 and "Tender for Labour AMC for maintenance and repairing of automobile air conditioning system of ASTC AC buses." on the top of the envelope and it should be addressed to the Managing Director, ASTC.
- 2. Tenders received late will not be considered and postal delay will not be entertained in case the bidder sends his tender through post or courier.
- 3. The tenderer is requested to go through the instructions; Terms and conditions carefully before quoting the rates in Tender Schedule and comply with the same.
- 4. The tenderer should satisfy & comply with all the terms and conditions and instructions, which are mentioned in the Tender Notice and in this tender document.
- 5. The corporation reserves the right to delete any item or items or to increase or decrease the quantity of any item or items from the tender schedule.
- 6. The Corporation reserves the right to accept or reject any/or all the tenders without assigning any reason thereof.
- 7. Tenderer should submit detailed statement for their specifications giving the details (facts) as to why not as per our specification, and submit the statement in his Technical bid i.e., envelope No. 1.

- 9. 10. Procedure for submission of Tender:Tenderershall have to submit two separate sealed envelopes as below:

i. The first envelope shall be addressed to the Managing Director ASTC, Guwahati. #### b) Envelope No.2 [Financial bid/ envelope for rates]:-

- 12. The tenderer should note that Envelope No.1 must contain the following documents:

  - d. Latest GST return filed
  - e. Dealership certificate
  - f. Trade registration certificate

Note: Envelope no. 2 will not be opened in case Envelope no. 1 does not contain any of the above mentioned documents and the offered tender will be liable for rejection.

13. The Tenderer should quote the **rates duly signed with date and seal of the firm in the financial bid** only. He should not quote the rates anywhere directly or indirectly in Envelope No.1. The rate should be quoted in both digits and letter and should not be overwritten. If done so, the tender will be rejected. The rate should be quoted in INR only.

- 14. If there is any correction in Tender, every correction/s in the rate should be initialized by the Tenderer or his authorized signatory.
- 15. Tenderer must follow all terms and conditions, instructions. If, he fails to follow any of the conditions and instructions, his/her Tender is liable for rejection.
- 16. The tenderer who meets our specification as well as quality of the item will be considered as successful bidder.
- 17. Tenderer, whose rates are accepted as per specifications & quality, will be informed about the same.
- 18. All correspondences shall have to be made in English and the rates in INR only.
- 19. A copy of tender document duly sealed & signed by authorized signatory of the bidder on each page should be submitted along with the technical bid.
- 20. Each page of the bid submitted by the bidder should be duly sealed & signed by the authorized signatory.
- 21. Training: The supplier will have to provide training to our representative/staffs free of cost from time to time as regards to maintenance of AC buses.
- 22. The original source of the items offered whether Indian or foreign should be clearly mentioned, and in case of the later, the exact country in which they are manufactured should be clearly stated against each article/equipment.
- 23. **Disputes:** In case of any dispute/ differences arises the same shall have to be settled amicably by mutual discussion between both the parties and if not settled amicably, it shall have to be settled in the Courts within the jurisdiction of Guwahati, Assam.
- 24. The Corporation may terminate the contract period if the tenderer is declared or any event occurs in relation to bankruptcy and insolvency as per norms.

#### TERMS AND CONDITIONS.

- 1. The GST rates, if any, whether inclusive or not, must be clearly stated in percentage and calculated in amount.
- 2. The tenderer should be an authorized service provider or registered firm/dealers for at least one of the reputed brands of Automobile Air conditions namely carrier, Voltas, Blue Star, LG, Lloyds, Toshiba, Spheros, Daikin. However they should have requisite expertise in servicing and maintenance of other brands of Automobile Air conditioners also. A copy of certificate/ Authorization letter issued by the company to the tenderer for being authorized service provider is to be submitted.
- 3. The tenderer must have its service centre at Guwahati and preferably in the major towns of Assam. Address proof for the office /branch is to be submitted.
- 4. The tenderer should have been engaged in providing Annual Maintenancy Contracts for automobile air conditioners for a minimum period of 3 (three) years to any Govt., Semi Govt. department, ASTCor State Transport Undertaking (STU).
- 5. The bidders should mention the technical details of their products.
- 6. The rates quoted in the Financial Bid shall be valid for the whole contract period.
- 7. The tenderer should have satisfactorily completed atleast one AMC to consider completion of 1 AMC. Completion certificate issued by the authorized officer of the client will have to be furnished along with the tender document. The Completion certificate along with the copy of the client's work order must clearly indicate:-a) Date of commencement of AMC b)Date of completion of AMC c) Nature of AMC d) Whether the AMC has been completed satisfactorily or not. e) Value of Air conditioner Tonnage involved in AMC.
- 8. The average of the annual turnover of the tenderer during the last three financial years ending March'2022 shall be more than Rs. 5 lakhs (Five lakhs only). A copy each of the Audited balances sheet along with profit and loss account statements for 3 financial years i.e. 2019-20 to 2021-22 should be submitted along with the Technical Bid. The tenderer shall have a valid PAN number. The copy of PAN number should be mentioned in the tender.
- 9. All the forms provided in the tender documents must be completed in full and all pages of tender documents must be signed and sealed before their submission.
- 10. The system of work shall be service providing of whose payment shall be as per contract and spares bill shall be as per actual.
- 8. <u>Inspection of Services:</u> Our divisional level Engineer will inspect the quality of service time to time during the contract period at the place of work.
- 9. Old parts, replaced with new parts, should be handed over to the concerned divisional level officer of the corporation immediately on completion of work.

- 10. All parts which require replacement should be replaced with genuine parts only of OEM/Authorized vendor by OEM, and the guarantee card of the part replaced should be deposited with the department along with the bill.
- 11. The service personnel of the selected bidder/ firm must inspect the ASTC buses at ASTC, ISBT Guwahati daily in coordination with ASTC Official before placement on service.
- 12. Preventative maintenance of vehicles after every 3 months that is 4 times a year.
- 13. In case of breakdown of vehicle the same shall have to be attended at site immediately en-route.
- 14. The Dealers/Firms shall maintain a job-card, preferably in duplicate. A copy of which will remain in possession of the AE/DE of the corporation. Whenever are pair job is required, the AE/DE of the corporation will release the job-card and the dealers/firms shall make entries of the repair jobs undertaken in the job-card and return it to the AE/DE of the corporation immediately after carrying the repair/service work.
- 15. The bill should be made as per the rates quoted in the tender and any amount higher than will be de ducted and payment would be made accordingly. The rate of parts should be equal to the company Pricelist. Discount if any shall have to be clearly mentioned on the bills, Only genuine parts will be provided during service and repair.
- 16. The bill should contain cost of spare parts (As per actual); job done and labor charges separately.
- 17. The bill, in triplicate, should be submitted to the divisional level officeimmediately on completion of the work. The Divisional level committee will forward the bills to H.O with their certification for payment.
- 18. No advance payment will be made.
