Sealed tenders eventually to be drawn on F-2 form affixing non-refundable IPO of Rs. 10.00 (Rupees ten) only with a validity period of 180 (One hundred and eighty) days only from the date of opening of tenders are invited from Registered eligible APWD (Building/Roads) Contractors for the Repairing of yard (Partial) at ISBT, Silchar and will be received in the office of the undersigned on 18/01/2024 (up to 2:00 PM only) and will be opened on 18/01/2024 at 3:00 PM in the office of the undersigned in presence of the tenderer or their authorized representatives if any. Bidding document may collected from the office of the undersigned from 05/01/2024 to 17/01/2024 at the cost of Rs.500 (Five hundred) only in the shape of Bank Draft of any scheduled nationalized Bank duly pledged to the Managing Director, ASTC, Paltanbazar, Guwahati-08

Details may be seen in the office of the undersigned during office hours on working days.

- If for any reason, the Date of receiving and opening of tenders happens to be a declared holiday, the tenders will be received and opened on the next working day at the same specified time and place.
- 2. If for any reasons the tenders cannot be opened in specified date and time, it will be notified accordingly.
- 3. Details of tender/ approved estimates may be seen in the office of the undersigned during office hours on 05/01/2024 onwards.
- 4. Tender documents will be issued in the office of the undersigned to the eligible contractors on payment of necessary cost of tender documents in the form of Bank Demand Draft only of any Nationalized Bank drawn in favour of the Managing Director, ASTC, Paltanbazar, Ghy-8 during office hours from 05/01/2024 to 17/01/2024. No tender paper will be issued after the specified date. The contractors will have to submit self-attested photo copies of their valid Registration Certificate, PAN Card and Registration Certificate with up-to-date clearance of GST & EPF along with the application for acquiring tender documents, without which no tender document will be issued to them.
- Tender must be submitted in sealed envelope addressed to the Managing Director, ASTC, Paltanbazar, Ghy-8, super-scribing the name of work tendered for enclosing self-attested photocopies of their valid Registration Certificate with up-to-date clearance of GST & EPF, up-todate Labour License, and PAN Card.
- 6. Tender must be accompanied by Bid Security of the amount as specified for the works in table above in the form of T.D.R. / F.D.R. of any Nationalized Bank only, duly pledged to the Managing Director, ASTC, Paltanbazar, Ghy-8 without requisite bid security shall be summarily rejected.
- 7. The tenderer should quote their rates considering GST and other levies payable by them on flat percentage basis above/ below/ at per the CPWD approved schedule of rates for the year 2021 at the specified spaces of Tender documents. Other rates which are not applicable must be stroked out properly.
- The rates and prices quoted by the tenderer shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- 9. The items of works and rates thereof are based on the CPWD approved schedule of rates for the year 2021

- 10. Sealed tenderer will have to deposit the security deposit money @ 2% (Two percent) of the Contract price, if the quoted rate is up to 10% (Ten percent) below the tender amount. In addition to the 2% (Two percent) S.D. money as above, additional S.D. money should also be deposited @ (Accepted rate minus 10%) of the contract price, if the quoted rate is beyond below 10% of the tender amount.
 - a. The S.D. money should be in the form of Term Deposit Receipts / Fixed Deposit Receipts of any Nationalized Bank of India duly pledged to the Managing Director, ASTC, Paltanbazar, and Ghy-8 within the stipulated period from the date of issue of Preliminary Work Order.
- 11. The selected tenderer will have to sign the formal tender agreement in F-2 form after depositing the necessary S.D. money.
- 12. The Managing Director, ASTC, Paltanbazar, Ghy-8 does not bind himself to accept the lowest tender and also reserves the right to reject any or all the tenders without assigning any reason thereof.
- 13. All terms and conditions for contract will be as per CPWD item rate F2 form and also printed general conditions and the contractors should read the same thoroughly in the office of the undersigned before submission of tender.
- 14. Income tax at the prevailing rate as applicable from time to time shall be deducted from the Contractor's Bills as per Income Tax Act and quoted rates shall be deemed to include the same.
- 15. The tenderer should quote rate inclusive of all taxes, duties, Sales Tax including GST and Service Tax on works contract and other levies inclusive of 1% labour Cess. The Managing Director will perform such duties in regard to the deduction of such taxes at source as per applicable law.
- 16. All tenders in which any of the prescribed conditions are not fulfilled or are incomplete in any respect are liable to be rejected.
- 17. No stock materials will be supplied by the Department. The contractor will have to arrange all materials required for the work at his/ her own risk and cost. The materials required will have to be procured from the authorized dealers and the quality of the materials should be as per ISI specification and also conforming to the specifications contained in the CPWD SOR for the year 2021. The same will be verified/ approved by the Managing Director concerned before utilization in the work. No extra payment will be made for this.
- 18. The Payment will be made on the availability of fund from the Govt.
- 19. The Press Notice and Detailed Notice Inviting tender are the part of the Tender documents.
- 20. These notices have to be read in conjunction with the tender document and have to be signed and submitted manually along with the bid.
