The tenders will be received by the office of the Managing Director, ASTC, Paltanbazar, Ghy-08. The tenders should be submitted in Two Bid (Technical Bid & Financial Bid) system in two separate envelops and both the envelopes should be super scribed as "Tender for Operating a Canteen at District Transport Officer Kamrup (M), Guwahati, Assam

A. The Technical Bid of each tender should contain the following:

- 1. Forwarding letter on the 'letter head' of the bidder with seal & signature
- Certificate of past Experience, having undertaken such operation in other Govt. /semi Govt. Organization.
- 3. An amount of Rs. 10000/- (Rupees Ten Thousand) only as Earnest Money Deposit in the form of Bank Draft to be pledged in favour of "Managing Director, ASTC, Paltanbazar, Ghy-08, payable at Guwahati.
- 4. Firm Registration Certificate/ Registration of sole proprietorship.
- 5. Valid GST Registration Certificate.
- 6. Trade License.
- 7. Food safety certificate.
- 8. Certificate under Shop & Establishment ACT.
- 9. All papers of the tender documents duly signed by the Bidder.

B. The Financial Bid of each tender should contain the following:

- 1. The Rate Schedule, quoting the rates (both in figures and words) of each item against the Menu [as specified by the Govt. in Annexure- 'A']
- 2. Tenders will be summarily rejected in the absence of the above.
- Tenders submitted, not in conformity with the above terms and conditions and having erases, overwriting etc, will also be rejected.
