- 6. The logo should be highlighted and the bus graphics should comprehend and enhance the same.
- 7. The alignment of the text should be horizontal keeping in mind the available surface.
- 8. Logo stickers: Use permanent stickers of reflective material (radium). The materials need to be UV resistant and waterproof.
