Assam State Transport Corporation (A.S.T.C.) invites sealed tenders in two bid system for "Procurement of various types of automotive lubricants" for ASTC vehicles from producing companies/ distributors/ authorized dealers.

Interested tenderers may collect the tender document for the category of item he/she is interested in from the office of undersigned on any working day during office hours on payment of Rs. 1000.00 (Rupees one thousand only) non-refundable in cash to the cash counter.

Any new information related to the tender documents will be published in the website only. In case, the tender document is downloaded from the website and tender is submitted, the tender document fee Rs.1000.00 in the form of bank draft drawn in favor of the Managing Director, Assam State Transport Corporation, payable at SBI, South Guwahati, Assam shall have to be submitted along with the technical bid.

Tenderer who had submitted tenders in response to NIT No. ASTC/HO/Tender/Lubricant/2021-22/1674 dtd. 23.07.2021 may submit fresh tender in pursuance of the re-tender notice or he may opt to retain his tender submitted earlier in that case he will have to give an undertaking to accept his previous tender.

4. Submission of Tender

The bidder has to submit the following along with the Tender at ASTC, Head Office, Paltan Bazar, Guwahati-781008 before the last date and time of submission of tender.

- A. The bidder has to submit two covers i.e Cover 1(TECHNICAL COVER) & Cover 2 (FINANCIAL COVER) which are to be enclosed in a common envelope super scribing the NIT No., NIT subject, address of the bidder. The common envelope should be addressed to the Managing Director, ASTC. The common sealed envelope should be submitted in the tender drop box in the office of the Managing Director, ASTC, Paltanbazar, Guwahati.
- **B.** The Technical cover must mention "**TECHNICAL BID**", NIT No., NIT subject and must include the filled up format provided in Annexure-I along with all the supporting documents duly signed along with seal of the bidder.

 The Financial cover must mention "**FINANCIAL BID**", NIT No., NIT subject and must

include the filled up format provided in Annexure-II, duly signed along with seal of the bidder.

- C. Earnest Money Deposit (Refundable) Rs. 50,000/-, Demand draft in favour of Managing Director, Assam State Transport Corporation, Payable at SBI, South Guwahati Branch. It should be provided in the **Cover 1(TECHNICAL COVER).**
- **D.** Tender Deposit Fees (Non refundable) Rs. 1,000/-, Demand draft in favour of Managing Director, Assam State Transport Corporation, Payable at SBI, South Guwahati Branch or at the

- cash counter of ASTC, HO, Paltanbazar, Ghy-08. It should be provided in the **Cover 1** (**TECHNICAL COVER**).
- **E.** Proof of Recommendation to use their product by the chassis manufacturer (TATA, Leyland, Mahindra, VOLVO, Bharat Benz, etc.) against different models of vehicles operated by ASTC should be furnished. It should be provided in the **Cover 1** (**TECHNICAL COVER**).
- **F.** The bidder has to submit completely filled format and attached documents in Annexure –I and Annexure –II.
- **G.** The Total rate mentioned in Price bid (format provided in Annexure-II) must be including all applicable taxes and charges (GST, transportation charge, etc.)
- **H.** In Price bid, the bidder shall quote for small and large packs as mentioned in format for price bid in Annexure-II.

5. Instructions to Bidders

- i. Assam State Transport Corporation (ASTC) invites sealed tender in two bids to this Tender from "Bidders" who meet the minimum eligibility criteria as specified in this tender document for "Procurement of automotive Lubricants".
- ii. Bids must be received not later than time, date and venue mentioned in the Fact Sheet. Bids that are received after the dateline WILL NOT be considered in this procurement process.
- iii. Selected bidder(s) would be required to supply Lubricants to the designated Offices of ASTC. In this regard, Assam State Transport Corporation (ASTC) would like to invite bids from qualified Bidders to supply said items as per the "Delivery Schedule" in this bidding document.
- iv. The Managing Director, Assam State Transport Corporation reserves the right to alter/cancel this tender process during anytime without assigning any reasons thereof. The decision of Managing Director, Assam State Transport Corporation will be final and binding to all.
- v. Any further information related to this tender will be given in ASTC website (www.astc.assam.gov.in) only. Bidders are informed to visit the same website regularly for any information.
- vi. The Corporation reserves the right to place an order to any party who is ready to supply on lowest rate for the items of the cancelled order, and corporation reserves the right to place an order on 2nd lowest rate if no supplier is ready to supply on 1st lowest rate for items for which the order was cancelled (the order was placed on 1st lowest but party fails to supply).
- vii. The rates quoted by the bidder must remain valid at least for the Financial Year 2021-2022, which may be extended later, until the next tendering process.

6. Scope of Work

All products should be offered in current production as of the date of the award. For purpose of this contract "current production" shall mean that the Lubricant is being manufactured as new PRODUCT for the Indian market. All PRODUCT ordered as stated in the tender must be shipped in fully sealed container (packets) with the required materials. The bidder(s) shall not quote and supply any PRODUCT that is likely to be declared as End of Service/ Support for twenty-four months from the date of bid submission. If any of the Product(s) is found to be declared as Expired in the period mentioned above, then the bidder shall replace within 15 days, all such products with the latest ones having same specifications without any financial obligation to ASTC.

7. Evaluation of bid

The "TECHNICAL COVER" containing technical bids of the bidders will be evaluated by the ASTC committee and the technically qualified bidders will be shortlisted for price bid evaluation. The "FINANCIAL COVER" containing price bids of technically qualified bidders only will be

opened and evaluated on the basis of lowest cost to the ASTC.

The opening date and time of financial bid shall be informed later to technically qualified bidders over phone/ email provided by them.

8. Award of work:

The award of work will be given to bidder on the basis of L1 (lowest cost to ASTC). Based on the Lowest cost against each item mentioned in tender document, award of work against different items may be given to multiple bidders.

9. Supply and Delivery of Lubricants

The selected bidder is expected to carry out all activities covering Supply including delivery, documentation, Testing, and Quality Inspection in coordination with representative of Managing Director, ASTC and other stakeholders of the procurement.

- i. Delivery is to be done at different stores of ASTC within the state of Assam by the party itself. The delivery cost has to be borne by the party.
- ii. Supply of all the required items having the specifications and in quantities as specified by the purchaser as mentioned in this tender shall be complete in all respect within 7 days of receipt of purchase order. In case of delay in delivery penalty @ 0.5% per day of the total purchase order value.
- iii. Conduct 100% Quality inspection and testing and ensure that each and every items complies to the specifications given in this tender and ensure that there should not be any physical damage(s) and shall contain all the required item before declaring them as "Ready for delivery".
- iv. The bidder will provide the soft copy and hard copy of both, listing every Product code to ASTC for better monitoring purposes.
- v. The vendor must mention the GSTIN of the firm along with the ASTC GSTIN in the Bills.
- vi. The Delivery Challan, Inspection Report & Acceptance Note will constitute the Final Acceptance of every product supplied as per the work order.
- vii. Managing Director, ASTC reserves the right to exempt the penalties, if any and also cancel the tender at any stage, without assigning any reasons thereof and the decision will be final and binding to all

10. Roles and Responsibilities

A. Assam State Transport Corporation (ASTC): ASTC shall

- (i) Conduct Pre-Delivery/Post-delivery Inspection
 - In-case of Pre-Delivery / Factory Sight Inspection, the bidder has to bear the entire cost including all arrangements except the travel cost which will be borne by ASTC.
- (ii) The Managing Director of Assam State Transport Corporation (ASTC) shall nominate a Committee for selection of bidder.
- (iii) Intimate regarding the details of the items will be delivered with the exact quantities to be delivered and the authorized person with mobile number who will receive the materials at Delivery.
- (iv) Authorize the concerned person of ASTC to sign on the Delivery Challan.

B. Right to alter Quantities

ASTC reserves the right to give repeat order to the L1 bidder in Respective Package based on the rates mentioned by the Bidder until next tendering process for Lubricants. Any decision of ASTC in this regard shall be final, conclusive and binding on the bidder. If ASTC does not purchase any of the tendered articles or purchases less than the quantity indicated in the bidding document, the bidder(s) shall not be entitled to claim any compensation.

C. Confidential Information

ASTC and Selected bidder shall keep confidential and not, without the written consent of the other party hereto, divulge to any third party any documents, data, or other information furnished directly or indirectly by the other party hereto in connection with the Contract, whether such information has been furnished prior to, during or following completion or termination of the Contract.

11. Paying Authority

The payments as per the Payment Schedule covered herein above shall be paid by ASTC. However, Payment of the Bills will be done with Good Receipt and satisfactory performance report of Lubricants from the Engineer-in-charge of central store/ divisional stores of Assam State Transport Corporation.

12. Payment Schedule

- i. Before release of any payment, the selected bidder must furnish the Manufacture and Expire of all Products failing which no payment will be released.
- ii. The selected bidder's request for payment shall be made to ASTC in writing, accompanied by invoices describing, as appropriate, the goods delivered and related services performed, and by the required documents submitted pursuant to general conditions of the contract and upon fulfilment of all the obligations stipulated in the Contract.
- iii. Due payments shall be made promptly by ASTC, generally within forty-five (45) days after submission of an invoice and other supporting documents in order.
- iv. The currency or currencies in which payments shall be made to the supplier/ selected bidder(s) under this Contract shall be Indian Rupees (INR) only.
- v. All remittance charges will be borne by the selected bidder.
- vi. In case of disputed items, disputed amount shall be withheld and will be paid only after settlement of the dispute.
- vii. Advance Payments will not be made.
- viii. Any penalties/ liquidated damages, as applicable, for delay and non-performance, as mentioned in this bidding document, will be deducted from the payments for the respective milestones.
