**Terms & Condition for supply of Tyre Tube & Flap**

Sealed Quotations are invited from authorised firm/dealers for supply of new retreading material for tyre retreading plant.

1. The validity period for the rates offered should be clearly mentioned and it should be minimum 1 (one) year from the date of opening of tenders & should conform to our specifications. The tenderers may please furnish their detailed specifications against each item, the relevant price list must accompany with the quotations.
2. The Warranty/KM achievable of new retreading material for tyre retreading plant should be mentioned clearly in the sealed quotation.
3. The authorised firm/ dealer has to produce authorisation letter from OEM.
4. The authorised firm /dealer of reputed brand of retreading material for tyre retreading plant has to submit photocopy of following documents with seal & sign of their firm/dealers.
  - a. PAN card
  - b. GST registration certificate.
  - c. Company registration certificate.
  - d. Voter Id –Proprietor/Registered owner.
  - e. Address proof of registered office
5. The last date of submission of quotations at the office of the Managing Director, Assam State Transport Corporation, Paltan Bazar, Guwahati is 6<sup>th</sup> March' 2023, 12:00 P.M. The bids will be opened on the same day at 12.30 P.M.
6. Tenders received late will not be considered and postal delay will not be entertained in case the bidder sends his tender through post or courier.
7. The tenderer is requested to go through the terms and conditions carefully before quoting the rates in tender schedule and comply with the same.
8. The tenderer should satisfy & comply with all the terms and conditions and instructions, which are mentioned in the tender notice.
9. The corporation reserves the right to delete any item or items or to increase or decrease the quantity of any item or items from the tender schedule.
10. Tenderer should submit detailed statement for their specifications giving the details (facts) as to why not as per our specification,
11. The Tenderer should quote the rates duly signed with date and seal of the firm.
12. Tenderer must follow all terms and conditions. If he fails to follow any one of it, his/her Tender is liable for rejection.
13. The tenderer who meets our specification as well as quality of the item will be considered as successful bidder.
14. Tenderer, whose rates are accepted as per specifications & quality, will be informed about the same.
15. All correspondences shall have to be made in English and the rates in INR only
16. Each page of the bid submitted by the bidder should be duly sealed & signed by the authorized signatory.



17. The rate should be quoted as **Freight on Road** destination at our Central Store, ASTC, Rupnagar Guwahati.
18. The GST rates should be inclusive.
19. The delivery period should be within 10 days from the date of issue of supply order & claim of transportation charges will not be entertained.
20. The items will be checked at the Corporation and acceptance is subject to the approval of the Corporation.
21. If the retreading material for tyre retreading plant or any part supplied is found damaged or manufacturing defect, the supplier will have to replace it within 24 hours from the date of detection. The rejected retreading material for tyre retreading plant shall have to be taken back by the supplier at their own cost.
22. **Inspection of Goods:** - The ordered item/s will be inspected by our representative at our Central store at the time of delivery. The Supplier should inform the date of delivery well ahead.
23. **Mode of Despatches:** - The retreading material for tyre retreading plant should be supplied at our C/store ASTC, Rupnagar, Guwahati. A copy of Invoice/ Bill along with Challan should invariably be accompanied with the supplied Tyre Tube & Flap.
24. Corporation reserves the right to cancel the supply orders, if bidders fail to supply the items within the delivery period.
25. The Corporation reserves the right to place an order to H2, if they are ready to supply on H1 rate, if the selected H1 bidder fails to supply of Tyre Tube & Flap within stipulated time period.
26. **Disputes:** - If any dispute or difference, question what so ever, arises, the same shall have to be settled within Guwahati, Assam Jurisdiction.
27. The decision of the Honourable Managing Director, ASTC will be final & binding to all.
