The interested bidders may inspect the unserviceable tyres at the locations on permission of the office/officers concerned, on any working day during office hours and quote the rates (both in figures and in words) against each lot. No unsealed tender will be taken into consideration. The rate so quoted in the tender(s) both in figures and words should not be over written. Tenderer(s) may also send their tenders by registered post in the name of Managing Director, ASTC, Paltanbazar, Guwahati-781008, which must reach the undersigned on or before 1-00 p.m. of 25.9.18. The corporation will not be responsible for any delay in delivery of the tenders by the postal authority or missing of the same in transit.

The successful tenderer(s) will be intimated after acceptance of the tender(s) and full amount have to be deposited by the concerned tenderer to this office within 10 (ten) days time from the date of intimation of such acceptance.

A photocopy of tender document with signature of the bidder in each page shall have to be submitted along with the tender.


