The vehicles will be leased out to highest bidder for running the vehicles under the banner of ASTC. The bidding system shall be done through offline mode.



1. Request for Proposal

In pursuance of BOD Resolution taken in the 182nd Meeting of BOD of ASTC, concurred by Transport Department vide letter No. TMV/E-20997/230 dated 21st March 2023 with inputs from Finance Department, Judicial Department and Center of Excellence in Public Procurement in Assam (CEPPA) and in view of deplorable condition of around 321 vehicles out of which 79 are beyond economical repair, 222 nos buses were proposed for lease through e-tender portal vide NIT No. ASTC/HO/CE (A&T)/089/Lease of ASTC Shutdown Vehicles/2022-23/0021, Dated: 27.04.2023 which has been concluded and LOA were issued accordingly.

In this regards out of the 222 nos the remaining 213 nos shutdown ASTC buses are proposed for lease to earn revenue for ASTC as well as for employment generation with a purpose of achieving the aggregator role as desired by the Government of Assam, The Managing Director, Assam State Transport Corporation (ASTC) Guwahati, (hereinafter referred to as the Authority), invites the tender in a single bid system for “leasing out, repairing and operation” of ASTC shutdown vehicles to interested bidders as specified in the tender.

The bidder is expected to respond to the requirements as completely and in as much relevant detail as possible, and focus on demonstrating bidder’s suitability to become the implementation partner of ASTC.

The bidders are expected to examine all instructions, forms, terms, requirements and other information in the tender document. Failure to furnish all information required as mentioned in the tender document or submission of a proposal not substantially responsive to the tender document in every respect will be at the Bidder's risk and may result in rejection of the proposal and forfeiture of the EMD.

2. Instruction to Bidders

General

- a) Bids are invited from interested bidders including individuals/company/firms/society/self-help groups etc. for lease out of shutdown vehicles of Assam State Transport Corporation which may be run by the bidder as per their requirement.

- b) A bidder can quote for only five vehicles at the maximum. The bidder has to mention the registration number of the vehicles against which he is bidding in his financial bid. The list of vehicles against which bids are invited is listed at Annexure-2.
- c) All information supplied by the Bidders may be treated as contractually binding on the Bidders, on successful award of the assignment by ASTC on the basis of this tender.
- d) The Bidder is advised to read carefully all instructions and conditions appearing in this document and understand them fully. All information and documents required as per the bid document must be furnished. Failure to provide the information and/ or documents as required will render the bid technically unacceptable.
- e) No commitment of any kind, contractual or otherwise shall exist unless and until a formal written Contract has been executed by or on behalf of ASTC. Any notification of preferred Bidder status by ASTC shall not give rise to any enforceable rights by the Bidder. ASTC may cancel this tender at any time prior to a formal written contract being executed by or on behalf of ASTC.
- f) This tender supersedes and replaces any previous public documentation & communications, and Bidders should place no reliance on such prior communication.
- g) The Managing Director, ASTC reserves the right to delete any item or items or to increase or decrease the quantity of any item or items from the tender schedule.
- h) The Managing Director, ASTC reserves the right to accept or reject any or all the tenders without assigning any reason thereof and is not binded to accept the highest rate.
- i) The Managing Director, ASTC reserves the right to cancel the tender process at any stage without assigning any reason thereof.
- j) Proposals must remain valid for 180 days after the submission date.
- k) Bids shall be received by ASTC in original hard copy, before the time and date specified in this tender. Original hard copy of bids technical/financial along with signed and sealed copy of the tender shall be submitted to: **Office of the Managing Director, Assam State Transport Corporation, Paltan Bazaar, Guwahati-781008.**
- l) In the event of the specified date for the submission of Bids being declared a public holiday by the Government of Assam, the Bids will be received up to the appointed time on the next working day. ASTC may, at its discretion, extend this deadline for submission of offers by issuing a corrigendum and uploading the same on ASTC's website <https://astc.assam.gov.in> only.
- m) Bids received later than the due time and date mentioned in the tender will not be considered for this bidding process.
- n) The Bidder in case of participation of firm should submit a Power of Attorney authorizing the signatory of the Proposal to commit the Bidder in case of participation of an organization/institution. The format prescribed for Power of Attorney is given at Annexure-4.
- o) Bidders must follow all terms and conditions and instructions of the tender. If he fails to follow any of the conditions and instructions, his bid is liable for rejection.
- p) All correspondences shall have to be made in English only.

3. Compliant Bids / Completeness of Response

- a. Bidders are advised to study all instructions, forms, terms, requirements and other information in the tender documents carefully. Submission of the Proposal shall be deemed to have been

done after careful study and examination of the tender document with full understanding of its implications.

- b. Failure to comply with the requirements of this paragraph may render the Proposal non-compliant and the Proposal may be rejected. Bidders must:
 - i. Include all documentation specified in this tender;
 - ii. Follow the format of this tender and respond to each element in the order as set out in this tender;
 - iii. Comply with all requirements as set out within this tender.

4. Issue of Corrigendum

- a. At any time prior to the last date for receipt of bids, ASTC may, for any reason modify the tender Document by a corrigendum.
- b. The Corrigendum or Re-tender (if any) will be posted only on ASTC's official website <https://astc.assam.gov.in> only.
- c. Any such corrigendum shall be deemed to be incorporated into this tender.
- d. In order to provide prospective Bidders reasonable time for taking the corrigendum into account, ASTC may, at its discretion, extend the last date for the receipt of Proposals.

5. Key Requirements of the Proposal

Tender Document Fees

- i. Tender can be downloaded from the ASTC's official website <https://astc.assam.gov.in>. Tender processing fee of INR 500/- (Rupees Five Hundred) is to be submitted by the bidder in favour of "Assam State Transport Corporation" Account No: 00000010281981361, Branch: SOUTH GUWAHATI(01244), IFS Code: SBIN0001244. The proof of payment details of the same is to be provided by the bidder along with the bid documents. The tender document fee is non-refundable.
- ii. Earnest Money Deposit ("EMD") of amount INR 2,000/- (Rupees Two thousand only/-) is to be submitted by the bidder against each vehicle bid along with the hard copy of the bid. The proof of bid security deposit to be provided with the bid document. Bid security to be deposited in favour of "Assam State Transport Corporation" Account No: 000000102881361, Branch: SOUTH GUWAHATI(01244), IFS Code: SBIN0001244.

For those bidders who have previously deposited the Earnest Money Deposit (EMD) in response to the tender under NIT No. ASTC/HO/CE (A&T)/089/Lease of ASTC Shutdown Vehicles/2022-23/0021, Dated: 27.04.2023, and in cases where their bids were rejected or they were not allotted a vehicle despite depositing EMD, they shall be granted an exemption from providing EMD equivalent to the amount deposited but not utilized for the leasing of buses as per the tender requirements.

- a) EMD of all unsuccessful Bidders would be refunded by ASTC Authority once the bidder is notified as unsuccessful. The EMD, for the amount mentioned above, of successful bidder would be adjusted in the Performance Security as per the tender and declaration of result.
- b) The EMD amount is interest free and will be refundable to the unsuccessful bidders without any accrued interest on it.
- c) The bid / proposal submitted without EMD, mentioned above, will be summarily rejected.
- d) The EMD may be forfeited:
 - If a bidder withdraws its Proposal during the period of Bid/Proposal validity.
 - In case of a successful bidder, if the bidder fails to sign the contract in accordance with this tender.

- If a Bidder engages in a corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice as specified in this tender;
- If the Selected Bidder fails, within the specified time limit to furnish the Performance Security within the period prescribed therefore in the tender.

6. Preparation and Submission of Proposal

Submission of Proposals

- Bidders are required to submit the complete Proposal i.e. The Bidder shall submit necessary technical bid, financial bid and submit original of Power of Attorney, Bid Security/ EMD and tender fee submission proof manually. The Authority will evaluate only those Bids that are received in the required formats and complete in all respects and Bid Security, document fee, POA are received in hard copies, in ORIGINAL. It should be duly sealed and signed by bidder/authorized signatory.
- The hard copy of snapshot of proof of tender processing fee, POA and EMD should be dispatched before the last date and time of bid submission as stated in the tender to the following address:

- Bidders should submit their responses as per the formats given in this tender.
- The hard copy of Power of Attorney, Bid Security/ EMD and tender fee submission proof is to be submitted to the procuring entity. The hard copies should reach to the office of the tender inviting authority before schedule date and time of the Bid submission. The Bidder has the option of sending the bid documents either by registered post or speed post or by hand delivery. ASTC shall not be responsible for any postal delay in receipt of the bid.
- Original copy of the EMD and hard copy of Proposal shall also be submitted to:

- All pages of the Bid, except for the Bid Security, and any other document executed on non-judicial stamp paper, forming part of the Bid and corrections in the Bid, if any, must be signed by the authorized signatory on behalf of the Bidder. It is clarified that the same authorized signatory shall sign all pages of the Bid. Further, any published document submitted with the Bid shall be signed by the authorized signatory. Bidder shall submit the Bid, duly signed by their authorized signatory.
- The cover of the envelope should clearly indicate the name, address, telephone number, E-mail ID and fax number of the Bidder to enable the Bid to be returned unopened in case it is found to be received after the time and date of Bid submission prescribed herein.
- The cover of the envelope should clearly indicate the name and reference number of the tender along with the bidder's complete details as stated above.
- All the pages of the Bid must be sequentially numbered and must contain the list of contents with page numbers. Any deficiency in the documentation may result in the rejection of the Bidder's Bid.
- The Bid shall contain no interlineations or overwriting, except as necessary to correct errors made by the Bidder itself. Any such corrections must be initialed by the authorized signatory of the Bidder.
- The sequence as delineated in the tender for submission of requisite documents must be followed and the hard copy of the documents as per Clause-6(a) to be submitted must be as per the sequence asked.

7. Clarifications To Bidder's Queries

The Bidders are requested to approach the respective Divisional Heads of ASTC for clarification of queries before the date of pre-bid meeting (i.e. 08.11.2023) queries will be addressed accordingly. Assam State Transport Corporation will address all the queries received from all the Bidders in the Pre-Bid meeting only. Assam State Transport Corporation reserves the right not to respond to questions raised or provide clarifications sought, in their sole discretion, if it is considered that it would be inappropriate to do so. Nothing in this section shall be taken or read as compelling or requiring Assam State Transport Corporation to respond to any question or to provide any clarification.

8. Right to No Selection and right to Withdraw the tender

- a. ASTC may terminate the tender process at any time and without assigning any reason. ASTC makes no commitments, express or implied, that this process will result in a business transaction with anyone.
- b. This tender does not constitute an offer by ASTC. The bidder's participation in this process may result in ASTC selecting the bidder to engage towards execution of the contract.
- c. ASTC reserves its right to vary, modify, revise, amend or change any of the terms and conditions of the Bid before submission. The decision regarding acceptance or rejection of bid by ASTC will be full and final.

9. Deadline for Submission of Proposals

10. Late Bids

- a. Bids received after the due date and the specified time (including the extended period if any) for any reason whatsoever, shall not be entertained and shall be returned unopened.
- b. The bids submitted by telex/telegram/fax/e-mail etc. shall not be considered. No correspondence will be entertained in this matter.
- c. ASTC shall not be responsible for any postal delay or non-receipt/ non- delivery of the documents. No further correspondence on this subject will be entertained.
- d. ASTC reserves the right to modify and amend any of the above-stipulated condition/criterion depending upon project priorities vis-à-vis urgent commitments.

11. Evaluation

Evaluation Process

- a. ASTC will constitute a Proposal Evaluation Committee to evaluate the proposals of the bidders which will include minimum 2 Nos external members.
- b. The Proposal Evaluation Committee constituted by ASTC shall evaluate the responses to the tender and all supporting documents / documentary evidence. Inability to submit requisite supporting documents / documentary evidence, may lead to rejection.
- c. The decision of the Proposal Evaluation Committee in the evaluation of responses to the tender shall be final. No correspondence will be entertained outside the process of negotiation/ discussion with the Committee.
- d. The Proposal Evaluation Committee reserves the right to reject any or all proposals on the basis of any deviations.

- e. Each of the responses shall be evaluated as per the criteria and requirements specified in this tender.
- f. Preference will be given to the unemployed youth, women applicants and specially abled applicants. (10%)

12. Tender Opening

- a) The bid/proposal of the bidders will be opened at 4:00 PM on 22th November, 2023 by the officer (s) authorized by ASTC, in the presence of such of those Bidders or their representatives who may be present at the time of opening.
- b) The representatives of such bidders may remain present at the time of opening of the bids.
- c) The representatives of the bidders are advised to carry an identity card or a letter of authority from the tendering firms to identify their bonafide for attending the opening of the proposal. The details of bonafide representatives must be sent to ASTC on a letter head of the company signed and stamped by authorized signatory.

13. Proposal Validity

The offer submitted by the Bidders should be valid for minimum period of 180 days from the date of submission of Proposal.

14. Bid Evaluation

- a. Bid scrutiny will be held as per the specifications given below and incomplete details as given below will be treated as nonresponsive, if Proposals:
 - Are not submitted as specified in the tender document.
 - Received without the Letter of Authorization (Power of Attorney).
 - Are found with suppression of details.
 - With incomplete information, subjective, conditional offers and partial offers submitted.
 - Submitted without the documents requested in the tender.
 - Have non-compliance of any of the clauses stipulated in the tender.
 - With lesser validity period.
 - In order to give priority to Unemployed Youth Male & Female Bidders & Physically Handicapped Bidders as listed in the categories mentioned in Clause 15 of this tender 7% of the total vehicles or minimum one vehicle per category will be reserved for unemployed Male & Female Youth and 3% of the total vehicles or minimum one vehicle per category will be reserved for the Physically Handicapped Bidders.
- b. Contents of Bid:
 - All documents establishing eligibility of the individual/firm/company/self-help group/society etc.
 - The Registration Number of vehicle from the list of vehicles provided by ASTC.
 - Rate per month to be quoted against each vehicle. (Quoted Rate must be above minimum fixed monthly rate per bus as per Clause-16 to be quoted by bidder)
 - Annexure-I duly filled by the bidder.

15. Documents establishing bidder's eligibility

The bidders shall along with the bid, provide satisfactory evidence acceptable to ASTC as given below:

The bidder should be domicile of the State of Assam in case of individual participant and documents establishing the same i.e. voter id, PRC, domicile certificate, etc. must be submitted along with bid. In case of individual participant, police verification is to be submitted as proof of no prior pending police case, legal proceeding against the individual. Priority will be given to unemployed youth and an undertaking is to be submitted by the bidder regarding their employment status. Also, preference will be given to women applicants and persons with disability. Additionally, no service holder can participate in this bidding process. In case a firm participates in the tender, the documents establishing formation of the firm in the State of Assam is to be submitted i.e. firm registration. The bidder shall have a net cash-flow of Rs.10.00 (ten) Lakhs in the last three financial years. The bidders that are graduate women, graduate unemployed youth, and physically disabled persons are exempt from the eligibility criteria requiring minimum cash flow in last three financial years.

Eligibility Conditions for different categories of bidders:

- i. Company/Firms/Society:
 - a. The bidder should be an entity registered in India under the Company Act, 1956 (or) a firm registered under the Limited Liability Partnership Act, 2008 (or) a firm registered under the Partnership Act, 1932 (or) a society registered under the provisions of the Societies Registration Act. XXI of 1860
 - b. The bidder should be domicile of Assam. The documents establishing formation of the firm in the State of Assam is to be submitted i.e, firm registration/ Certificate of Incorporation/ Partnership Deed in case of Partnership firm/ Memorandum of Association in case of Society.
 - c. The bidder shall have a net cash flow of Rs. 10.00 (ten) Lakhs in the last three financial year.
- ii. Individuals/ Self Help Group:
 - a. Unemployed female (Unmarried/widow) Youth Bidder:
 - i. The bidder should be domicile of Assam. The documents establishing the same i.e, voter id, PRC, domicile certificate etc. must be submitted along with bid.
 - ii. A police verification is to be submitted as a proof of no prior pending police case, legal proceeding against the individual.
 - iii. Must be Higher Secondary passed from Govt. recognized school/college (certificate to be enclosed).
 - iv. Cash flow is not required
 - v. EMD is exempted
 - vi. Two months performance security is to be submitted
 - b. Unemployed Male Youth Bidder:
 - i. The bidder should be domicile of Assam. The documents establishing the same i.e, voter id, PRC, domicile certificate etc. must be submitted along with bid.
 - ii. A police verification is to be submitted as a proof of no prior pending police case, legal proceeding against the individual.
 - iii. Must be Graduate passed from Govt. recognized college/university (certificate to be enclosed).
 - iv. Cash flow is not required
 - v. EMD is exempted
 - vi. Two months performance security is to be submitted

c. Unemployed Person with Disability:

- i. The bidder should be domicile of Assam. The documents establishing the same i.e, voter id, PRC, domicile certificate etc. must be submitted along with bid.
- ii. A police verification is to be submitted as a proof of no prior pending police case, legal proceeding against the individual.
- iii. Disability Certificate and Unique Disability ID issued by component authority
- iv. Cash flow is not required
- v. EMD is exempted
- vi. Two months performance security is to be submitted.

16. Scope of Contract

ASTC will allot the shutdown vehicles to the H1 bidder. The successful bidder will repair the allotted vehicles completely at their own cost and operate the vehicles in accordance with the general conditions of contract specified in the tender. The vehicles will be allotted to the H1 bidders that quote the highest rate above the minimum rate per month against the buses as fixed by ASTC authority:

For the buses listed in Annexure-2:

1. Category-A : Rs.9,000/- per month + 18% GST. (Estimated Repairing cost approx. Rs. 7 Lakhs and above)
2. Category-B: Rs. 14,000/- per month + 18% GST. (Estimated Repairing cost Rs. 4 Lakhs to Rs. 7 Lakhs)
3. Category-C: Rs. 16,500/- per month + 18 GST. (Estimated Repairing cost Rs. 2 Lakhs to Rs. 4 Lakhs)
4. Category-D : Rs. 19 ,000/- per month + 18 GST. (Estimated Repairing cost upto Rs. 2 Lakhs)

N.B.: The categories have been fixed based on the assessment done on the present condition of the buses. However, it is to be noted that the approximate estimated cost for repairing the vehicles may increase or decrease from the previously estimated cost of repairing as the estimates were prepared without dismantling the vehicles. ASTC will not be liable for any actual changes in the estimated repairing cost at the time of repair.

17. General Conditions of Contract

- i. The selected bidder will have to operate the bus for the remaining life of the vehicle under the banner of ASTC upto 15 years age of the vehicle from the date of registration and if the bidder wishes to surrender before the stipulated time his/her security deposit will be forfeited.
- ii. The selected bidder will repair and operate the bus within two months from the date of signing of agreement. If the bus is not operational within two months the selected bidder will be served a warning and further action will be taken including repossession of the bus from the selected bidder and complete Performance security amount will be forfeited.
- iii. The selected bidder will get all the public service facilities at ASTC bus terminus.
- iv. The bidder will be responsible to collect the NOC as per format attached as Annexure-3 from respective Divisional Superintendent to be submitted along with

the bid for allotment of route and time. The preferred routes shall have to be submitted as per the format at Annexure-3

- v. The ASTC logo should be used in each vehicle. No individual banner/logo/graffiti of the bidder is allowed and if found so penalty will be levied against the concerned bidder. The advertisement on the buses will be in the scope of ASTC and the revenue from any such advertisement will go to ASTC.
- vi. The selected bidder will arrange for ASTC approved Speed governor, Electronic ticketing device, GPS tracking system, CC Camera (in front, rear and inside the bus), etc.
- vii. The uniform for driver & conductor will be mandatory and it will be provided by the selected bidder. The driver and conductor will possess the necessary documentation (Driving License & for the work, the same is to be ensured by the bidder).
- viii. The buses will charge fare from passengers strictly as per approved rates of ASTC and as per Govt. fare structure notification in force.
- ix. In case of gross misbehavior by the driver or conductor of the bus, the agreement shall be liable for termination and security money will be forfeited.
- x. The movement of buses shall be recorded and monitored by ASTC App through the GPS devices fitted in them and the selected bidder will be responsible for ensuring up-keep of the GPS devices and Service level Agreements, signed with ASTC. Also E-ticketing system which is being implemented by ASTC shall be applicable for all buses.
- xi. All other liabilities of the vehicle will be borne by the selected bidder.
- xii. The salary, trip allowance of the vehicle crew members as per prevalent Govt. norms will be borne by the selected bidder. The selected bidder will strictly follow the stipulations of the M.V. Act 1988 read with Assam M.V Rules 2003 and any Amendments thereafter.
- xiii. **The selected bidder will pay Rs. 10,000.00 (Rupees Ten Thousand) only + 18% GST per vehicle at the time of allotment order of the vehicle as registration fee. The registration fees to be deposited in the Bank Account of Assam State Transport Corporation, Account No: 00000010281981361, Branch: SOUTH GUWAHATI(01244), IFS Code: SBIN0001244. The registration fee is non-refundable.**
- xiv. The monthly amount payable to ASTC should be paid within 7th of every month without fail and the same will be paid to concerned ASTC authority. In case the selected bidder does not clear his dues for 3 consecutive months, the agreement may be cancelled after a written notice by ASTC and post cancellation of agreement ASTC will seize the vehicle from the selected bidder. In case the vehicle is damaged beyond economic repair the lessee will be fined at the rate specified by ASTC.
- xv. In case of accident, selected bidder will be fully responsible in recovery and repair of bus, all types of legal issues, medical treatment to the injured persons involved in the particular accident, etc..
- xvi. The selected bidder will be responsible for the insurance of the vehicle which will have to be comprehensive in nature so that any vehicle damages are also included under the insurance. The selected bidder should keep his bus duly insured and Pollution tested. Road tax payment is exempted for the ASTC buses.

- xvii. The selected bidders will have to follow all norms and fit the vehicle with GPS system, CCTV etc. as per prevalent norms and for easy integration into the Intelligent Bus Transport Management System (IBTMS) project in the future.
- xviii. The procurement of Monthly Log Book from the respective ASTC Station will be mandatory on payment of monthly share money as per the rate quoted by the selected bidder. The monthly share money has to be deposited at the beginning of the month within first 7 days. In case the 7th day is a holiday the next working day will be treated as the deadline for payment to ASTC Authorities at the rate quoted by the bidder per month. ASTC Authorities shall be offering a 10% concession on the Share money to be deposited in case the total share money is deposited within 1st seven days of the current month.
- xix. In case of more than three genuine complaints received for non-stoppages of the bus at the scheduled bus stops in a month, strict action will be taken including the termination of agreement and forfeit of security deposit. However, it does not restrict in collection of wayside passengers.
- xx. ASTC will not be responsible for any damage or loss to the bus during any kind of bandh, agitation, etc.
- xxi. The selected bidder shall be responsible in case of proper prosecution of proceedings before Motor Accident Claims Tribunal (MACT), Commissioner for Workmen compensation, Regional Transport Authority and State Transport Authority.
- xxii. ASTC Authorities will neither be liable for any kind of accident or breakdown of the vehicle nor be liable to pay any claim / compensation arising out of any kind of accident. All such claims will be as per coverage of Insurance from the Insurance Company only. ASTC Authorities will not be responsible in defending the driver in the Criminal case or claim case either before the Motor Accident Claims Tribunal (MACT) or any other Civil Court.
- xxiii. In case of major / fatal accident due to erroneous behavior of the driver / conductor, a fine of Rs. 500.00 (Rupees Five Hundred) only + 18% GST will be imposed on the selected bidder and the driver will have to be debarred immediately. ASTC Authorities will blacklist the driver debaring him from driving other vehicles under ASTC and in case such black listed driver is appointed in any other vehicle, operation of that bus will also be stopped, and the agreement will be liable to be terminated.
- If a vehicle is involved in a major/ fatal accident and the driver is found without a valid license, the operation of the bus will be suspended for 3 months (However, 50% of the minimum monthly share money shall have to be paid for the suspended period).
- xxiv. The selected bidder will be liable to pay penalty levied by the ASTC officials at the specified rates for the following offences:
1. Non operation of bus
 2. Misbehavior by the drivers, conductor, selected bidder or his representatives.
 3. Passenger's complaint
 4. Plying of the bus in a route other than the specified route in the permit.
 5. Any activity detrimental to ASTC

- xxv. The transfer of ownership is not permitted and subletting is also not allowed and if found so will be penalized heavily.
- xxvi. The selected bidder should give a notice of at least 48 hours to ASTC authority when the Bus is not likely to be made available for service on any particular day. While violation of the same will be viewed seriously by the Authorities and may attract penalties upto Rs. 500/- per day.
- xxvii. The vehicle will not be permitted to carry goods other than passengers' belongings and the buses shall have to carry postal mail bags of ASTC and the selected bidder cannot claim any charge for it.
- xxviii. 2(two) seats of the vehicle should be kept as reserved for specially abled person & senior citizen.
- xxix. In case of suspension or cancellation of permit or in the event of the bus being put out of operation due to any legal action/order of the court or statutory Authority, ASTC will not be liable for payment of any damage or compensation for abrupt termination of the agreement.
- xxx. Any kind of other expenditures like toll charge, parking charge, road tax, insurance, pollution certificate, fitness certificate, etc. will have to be borne by the selected bidder.
The vehicle must not be plied without valid fitness certificate as per the applicable norms at the time.
- xxxi. The selected bidder may file an appeal within fifteen days of the communication of the decision taken under any clause, such an appeal shall be heard by the Managing Director or any other officer authorized by him by a special or general order and the decision so made shall be final and binding on the selected bidder.
- xxxii. In the event of any dispute out of the agreement, the same will be referred to sole arbitration of the Chairman, ASTC, who may decide the same himself or appoint any person to decide the same and the decision of the Chairman, ASTC or the person appointed/nominated by the Chairman, ASTC shall be final and binding on both the parties.
- xxxiii. Notwithstanding anything to the contrary contained in any of the terms and conditions of the tender, MD, ASTC shall have the absolute right to suspend forthwith operation of the bus for periods not exceeding seven days at a time for major lapse/default particulars of which are given in the agreement by the selected bidder.
- xxxiv. The selected bidder will have to abide by the Motor Vehicle Act 1988 and subsequent amendments.
- xxxv. The selected bidders will be required to be physically present at the ASTC Head Office, Guwahati at the given date and time announced for the purpose for signing of Agreement with ASTC Authority in presence of the Managing Director, ASTC and the Law Officer of the Assam State Transport Corporation (ASTC) stating that they will follow all the terms & conditions as stipulated in the tender.
- xxxvi. The selected bidder shall abide by the orders of the MD, ASTC or any Officer authorized by him by a special or general order in regard to operation of buses from time to time.
- xxxvii. The selected bidder shall ensure to abide by any notifications/guidelines issued by the Central Government and/or Govt. of Assam.

- xxxviii. ASTC shall not provide any break-down service for the bus to the selected bidder. It shall be the sole responsibility of the selected bidder to make arrangements for attending break-downs of his/her bus at his/her own cost.
- xxxix. The selected bidder of the bus/buses or his/her driver shall not indulge in any subversive activity causing setback to ASTC revenue or in any way disrupt the normal service or bring disruption to it or cause inconvenience or harassment to commuters. The decision of the Managing Director (MD), ASTC or any other officer authorized by him by a special or general order shall be binding on the selected bidder.
- xl. The selected bidder of the bus/buses have to provide their vehicles as and when required or desired by Govt. of Assam/ASTC at the time of any disaster/pandemic or during any emergency bus operation.
- xli. If deemed necessary the driver shall have to undergo medical examination by registered doctors as approved by ASTC regarding his/her fitness.
- xlii. ASTC authority will provide the list of 213 Nos shutdown vehicles of ASTC which includes Ashok Leyland (Jan Bus), Tata Ultra buses, Tata RCV, Volvo Buses, etc. against which the bidders will submit their bids.
- xliii. The bidders will have to survey the vehicle on their own and consult relevant OEM dealers if necessary for the repairing details before submission of their bids against each vehicle. ASTC authority will provide the buses in "AS IS WHERE IS" condition. The bidders will have to move the vehicles allotted to them from ASTC premises within 30 Days from the allotment and signing of agreement. The repairing of the buses in ASTC premises will not be permitted under any circumstance whatsoever and any application of bidders to that end will not be entertained by ASTC authority. In this regard if the allotted vehicles are not lifted by the selected bidder within 30 days after the elapse of which a ground rent of Rs.100/- (Rupees One Hundred Only/-) will be charged per day till the vehicle is lifted by the selected bidder. The ground rent will be realized upto 30 days from the elapse of the initial 30 days time given for the lifting of the vehicles from the ASTC premises. On completion of the above period, the agreement with the concerned bidder will be terminated and the security deposit submitted by him will be forfeited.
**N.B.: In case of Ashok Leyland (Jan buses) and Volvo buses which are designed as special purpose vehicles under JnNURM-II Scheme, the interested bidders are advised to consult the OEM dealers of these vehicles for necessary repair and maintenance support.
- xliv. The buses will have to be returned to ASTC authority on completion of 15 years of life of the vehicles from the date of registration for onward scrapping of the vehicles as per the prevalent Vehicle Scrapping Policy of the Government. In case the vehicles are handed over to the bidder with tyres and batteries, the original tyres and batteries shall have to be returned to respective division by the selected bidders.

18. Process to be confidential

After the public opening of bids, information relating to the examination, clarifications, evaluation and comparison of bids and recommendations concerning the award of contract shall be confidential and shall not be disclosed to other persons not

officially concerned with such process. Disclosure to any such persons shall be made in confidence and shall extend only so far as it may be deemed necessary for the purposes of such performance.

19. Award of contract

Subject to adherence to all terms and conditions as stipulated in the tender, ASTC Authority will consider the bidder whose bid has been determined to be responsive, complete and in accordance with the tender and whose offer on evaluation has been determined to be the acceptable offer for award of contract.

20. ASTC right to accept any bid and to reject any or all bids

ASTC reserves the right to accept or reject any bid, and to annul the bid process and reject all bids without assigning any reason.

21. Performance security

Within 15 days of dispatch of the 'Letter of Award' from ASTC, the successful bidder shall furnish a performance security of amount equivalent to total monthly payable amount for 6 (six) months, which is refundable at the end of agreement tenure. The performance security to be deposited in favour of "Assam State Transport Corporation" Account No: 00000010281981361, Branch: SOUTH GUWAHATI(01244), IFS Code: SBIN0001244. Proof of submission of Performance security should be provided before signing of agreement.

22. Corrupt practices

Bidders are expected not to indulge in any corrupt and fraudulent practice. They are expected to observe the highest standard of ethics during the bidding process and execution of the contract. In pursuance of this policy, following definitions are relevant:

- i. "Corrupt practice" means the offering, giving, receiving or soliciting of anything of value to influence the action of a public official in the bidding process or in contract execution; and
- ii. "Fraudulent practice" means a misrepresentation of facts in order to influence a bidding process or the execution of a contract to the detriment of the Authority inviting bids, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the Authority of the benefits of free and open competition;

If it is found that bidder(s) had engaged in corrupt/fraudulent practice in securing and executing the contract, ASTC reserves the right:

- (a) not to award contract to such bidder,
- (b) to cancel the contract, if already awarded. In case of cancellation, the authority shall be entitled to recover from the bidder the amount of any loss arising from such cancellation in accordance with the provisions of the bidding documents. ASTC Authority shall also have the right to forfeit the performance security of such bidder, and
- (c) to ban the business dealing with the bidder who engaged in such practices either indefinitely or for a specified period of time

23. Termination for default

ASTC Authority may, without prejudice to any other remedy for breach of contract, by written notice of default sent to the selected bidder, terminate the contract in whole or in part:

a) if the selected bidder fails to execute their responsibilities as specified in the tender/contract

b) if the selected bidder fails to perform any other obligation(s) under the contract.

In the event ASTC terminates the contract in part, the selected bidder (whose Contract is terminated) shall be liable to the authority for the execution of the contract for the non terminated part. The selected bidder shall continue performance of the contract to the extent not terminated.

Thereafter, ASTC shall approach H2 bidder to fulfill the remaining contract or full contract (in case whole contract is terminated) at H1 rate only with the same terms and conditions as per this tender.

24. Force majeure

For purposes of this contract, Force Majeure means an event beyond the control of the parties to the contract and not involving either party's fault or negligence and not foreseeable.

If, at any time during the existence of the contract, either party is unable to perform in whole or in part any obligation under this contract because of an event rendering performance of obligations impossible which include acts of God, war, revolutions, hostility, civil commotions, strikes, fires, floods, earthquake, epidemics, quarantine restrictions, freight embargoes or explosions, then the authority will consider the selected bidder request for extension during the period when such circumstances are operative.

The party which is unable to perform its obligations under the present contract shall, within seven (7) days of occurrence of the Force Majeure event, inform the other party with suitable documentary evidence.

Any waiver/extension of time in respect of the implementation of the contract shall not be deemed to be a waiver/extension of time in respect of the remaining balance portion of contract.

If such inability on account of force majeure to perform continues for a period of more than three (3) months, each party shall have the right to be released from further performance of the contract, in which case, neither party shall have the right to claim damages from the other. All prior performance shall be subject to contract terms.

25. Safety measures

The Selected bidder should take all precautionary measures in order to ensure the protection of his own personnel moving about or working under him/her.

The Selected bidder should abide by and conform to all the rules and regulations of ASTC in force from time to time and ensure that the same are followed by his representatives, agents, or workmen working under him/her.

The Selected bidder should ensure that while working, unauthorized, careless or inadvertent operation of installed equipment which may result in accident to staff and/or damage to equipment, does not occur.

The Selected bidder should indemnify and keep ASTC authority indemnified and harmless against all actions, suits, claims, demands, costs, charges or expenses arising in connection with any accident, death or injury, sustained by any person or persons and any loss or damage to property of ASTC sustained due to the acts or omissions of the Selected bidder

irrespective of whether such liability arises under the Workman's Compensation Act or the Fatal Accidents Act or any other statute in force from time to time.

26. Insolvency and breach of contract

ASTC authority may at any time, by a notice in writing summarily determine the contract without compensation to the selected bidder in any of the following events, that is to say:-

a) if the selected Bidder being an individual or if a firm, any partner thereof, shall at any time, be adjudged insolvent or shall have a receiving order or order for administration of his estate made against him or shall take any proceeding for composition under any Insolvency Act for the time being in force or make any conveyance or assignment of his effects or enter into any assignment or composition with his creditors or suspend payment or if the firm be dissolved under the Partnership Act, or

b) if the selected bidder being a company is wound up voluntarily or by the order of a Court or a Receiver, Liquidator, or Manager on behalf of the Debenture holders is appointed, or circumstances shall have arisen which entitle the Court or Debenture holders to appoint a Receiver, Liquidator or Manager, or

c) if the selected bidder commits any breach of the contract not herein specifically provided for. Provided always that such determination shall not prejudice any right of action or remedy which shall have accrued or shall accrue thereafter to ASTC and provided also the selected bidder shall be liable to pay to ASTC any extra expenditure he/she is thereby put to and the selected bidder shall, under no circumstances, be entitled to any gain on repurchase.

27. Dispute Resolution & Laws governing the contract

In case any difference/dispute arises between the parties during the period of the agreement, the same may be settled amicably by all the parties and in case of failure such difference/dispute may be referred to the Chairman, ASTC and his decision shall be final and binding on all the parties.

- **Governing Law**

This Contract shall be governed by and construed in accordance with Indian Laws and Local Laws.

- **Jurisdiction**

The parties irrevocably submit to exclusive jurisdiction of the State of Assam in all matters arising under this Agreement.
