Tenders in sealed cover super scribed with the words " TENDER FOR PURCHASE OF UNSERVICEABLE VEHICLES" are invited from interested persons/ firms for purchase of old and unserviceable vehicles of Assam State Transport Corporation (as per list attached) in their "AS IS WHERE IS" condition which will be received in the office of the Managing Director on or before 23-08-2019 up to 1.30 p.m. during office hours on all working days and will be opened at 2.30 p.m. on the same day i.e.23-08-2019 The tenderers or their authorized representatives may remain present at the time of opening the tenders. The interested purchasers may inspect the vehicles, on permission of the ASTC officer/ officers concerned of its location, on any working day during office hours and quote the rates (both in figures and in words) against individual vehicles intended to be purchased. The rate quoted should be in INR. No open tender will be considered. The rate so quoted in the tender(s), both in figures and words should not be over-written. The tender in sealed cover shall have to be dropped in the drop box placed at HO,ASTC, Paltanbazar, Guwahati-8 within the scheduled time. Tenderer/tenderers may also send their tenders by registered post in the name of Managing Director, A.S.T.C, Paltanbazar, Guwahati-781008, which must reach on or before 1.30 P.M. of 23-08-2019.The corporation will not be responsible for any delay in delivery of the tenders by the postal authority or missing of the same in transit.

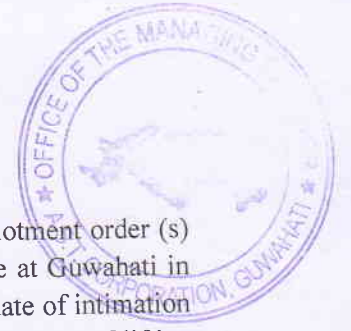
Tenders will be accepted only on original tender papers obtained from the office of the Managing Director, A.S.T.C, on payment of Rs. 500.00 (Non-refundable) only in cash during office hours on working days. The rate quoted should be in INR. The tender papers can also be downloaded from our website [astc.assam.gov.in](http://astc.assam.gov.in). In that case the tender fee of same amount shall have to be submitted in the form of DD in favour of Managing Director, A.S.T.C, Paltanbazar, alongwith the tender.

If the total nos. of vehicles for which rates are quoted exceeds the limit in the form, additional photo copies of tender form may be used and every pages should be signed by the bidder.

Tenderers must furnish proper address, Contact no, PAN No, etc. in their tender. Tender without proper address may not be accepted by the Corporation. A copy of tender document duly signed by the bidder in each page shall have to be accompanied with the bid submitted.

The tenderers will have to furnish along with their tenders an earnest money of Rs. 10,000.00 (Rupees ten thousand) only for each vehicle by Demand Draft drawn on any Nationalized Bank payable at Guwahati in favour of the Managing Director, A.S.T.C , Guwahati (Cash payment in the event of any emergency may be considered by the Managing Director, if formally applied for). In case submitting tender for a group of vehicles, the tenderer shall furnish the Earnest money for all the vehicles in the group. If the E/M, so furnished by the tenderer, is incomplete, i.e. the Earnest money does not cover all the vehicles tendered for, the tender will be rejected by the tender opening committee straight way for the entire group of vehicles. For earnest money of the tenders which are not accepted will be refunded to the tenderers concerned. The earnest money is interest free.

The tenderers either may quote their rates against each vehicle separately or for the entire lot of 108 vehicles of the same list attached herewith offers will not be accepted. GST will be charged extra as applicable on the price of sale.



The successful tenderer(s) will be intimated after acceptance of the tender(s) through allotment order (s) and the full amount must be deposited by Demand Draft on Nationalized Bank payable at Guwahati in favour of the Managing Director, ASTC, Guwahati, within 10 (ten) days time from the date of intimation of acceptance. The vehicles are to be removed within 10 (ten) days time from the date of issue of lifting order which will be issued on receipt of full payment of the vehicles. In case of failure to remove the vehicle/vehicles within the specified period, the vehicles will remain absolutely at the risk of the successful tenderers, who will be liable to pay ground rent @Rs. 200.00 (Rupees two hundred) only per day per vehicle beyond the allowable time limit.


If the successful bidders refuse or fail to pay the full amount within the stipulated time, the earnest money so deposited by him/them will be forfeited to the corporation besides recovering the loss that may be sustained by the corporation in disposing of the vehicles, otherwise from the amount lying with the corporation or any other account.

The Managing Director, ASTC, Guwahati, reserves the right to accept/reject any tender(s) and withdraw from sale any or all vehicles without assigning any reason thereof. Besides if any tenderer offers the rate for the entire lot of 108 nos. of vehicles and his bidding amount is more than the total reserved value irrespective of individual vehicle wise amount, ASTC has reserved the right to consider his case favourably.

The tender should be submitted in a sealed cover super scribed with the words "TENDER FOR PURCHASE OF UNSERVICEABLE VEHICLES" and shall have to be dropped in the drop box provided in the office of the Managing Director, ASTC, Paltanbazar, Guwahati-08 before the last date and time of submission of tender. The envelope should be addressed to the Managing Director, ASTC. The name and address of the bidder and NIT ref no. should also be mentioned on the cover.
