Terms and Conditions for allotment of (G+4) with basement parking of ASTC Station, Badarpur.


- 1. The quotationers to be quoted on registration fee (minimum registration fees is Rs. 7,00,000.00) both in figure and words. The registration fees are not refundable. Bidding documents may be collected from the office of the Managing Director, ASTC, Paltanbazar, Guwahati during office hours upto 3.00 p.m of 16/02/2021 at the cost of Rs. 1000.00 (Rupees One thousand) only by depositing draft of any Scheduled bank duly pledged to the Managing Director, ASTC ,Paltanbazar, Guwahati which is not refundable. The last date for receiving quotation is 19/02/2021 upto 2.00 pm. Quotations will be opened on same day i.e 19/02/2021 at 3.00 pm. Quotationers or their authorised representative may be present at the time of opening of quotations if desires. In absence of any representative the authority has the right to open the quotations as deem fit. Quotationer should mention "Quotation for allotment of (G+4) with basement parking ASTC Station, Badarpur" on the top of the envelop submitted by them. Unsealed quotations will be treated as non-responsive.
- 2. Cost of construction for (G+4) with basement parking is Rs. 6,32,91,700.00. At any cost this amount should not be exceeded.
