## Terms and Conditions for allotment Space at ISBT, Tezpur,

- 1. The quotationers have to be quoted rate on fixed minimum charge/ fee is ie Rs 10.00 (Rupees Ten) ) only per Sq.ft excluding G.S.T, electricity charges and other taxes as Applicable Time to time.
- 2. The monthly charge/ fee, GST AND Electricity charges shall be paid to the Divisional Superintendent ASTC, Tezpur in the 1st week of each calendar month.
- 3. The registration fee fixed as Rs. 2,00,000.00 which is non refundable. As per last BOD minutes (177 item no 15) 20 % of R.F have to be paid within 7 (Seven) days from the date of issue of the provisional allotment order and balance 80% have to be paid after completion of the project. 20% R.F have to be paid in the shape of Bank Demand draft in favour of Managing Director, ASTC, Paltan Bazar, Ghy-08. Final allotment order will be issued after completion of the project.
- 4. Further you will have to pay Six (6) month rent excluding GST as security deposit. This security deposit money will have to be deposited after completion of the project as well as before handing over the said allotted space.
- 5. The cost of internal decoration will have to be done from your end, which is non refundable or non adjustable.
- 6. You will have to keep the area clean at your own cost.
