The Chief Accounts Officer of the Assam State Transport Corporation shall be responsible for streamlining the Financial Structure, Budget including Accounts and Audit as envisaged under Chapter-V, Chapter-VI and Chapter-VII under the Assam state Road Transport Corporation Rules 1970, and also, strict adherence to the Assam Financial Rule, Fundamental Rules and Subsidiary Rules or any other Law/ Central government or State Government standing instructions for ensuring fiscal discipline in all offices of the Assam State transport Corporation. This order shall come into effect immediately and remain in force for another 11 (eleven) months from the date of joining of the incumbent concerned.
