
The incumbent concerned are directed to submit their joining report to the concerned Drawing & Disbursing Officer along with physical fitness certificate from District Medical & Health Officer within 15 (Fifteen) days time from the date of issue of this appointment order failing which the appointment order shall automatically stands cancelled without any further notice.

Further, they are asked to ensure submission of Original Police Verification report from the respective office of the Superintendent of Police/Commissioner of Police for Kamrup (Metro) within 6(six)months time from their date of joining. If there will be any adverse report found in PVR against him/her, then this appointment letter shall automatically cancelled.

This appointment is purely temporary and on probation for 6(Six) months and subject to confirmation against regular post as per rule and shall come into effect from the date of joining of the incumbent concerned. They shall draw their monthly pay and allowances from the respective establishment of their place of posting.


