Whereas Assam State Transport Corporation has initiated and started new business with Oil India Ltd. Duliajan and LOA for deployment of 10 Nos. of Non A.C. buses for 5(Five) years on contract basis has been received. In view of urgent requirement of Drivers to operate the newly procured business with Oil India Ltd. Duliajan, Employment Notice was published vide No. ASTC/HO/HIRING DRIVER/1997/2020/Pt.I/0425 dated.11th January,2022 through the Dainik Janambhumi (Jorhat Edition) published on 12th January,2021.

Accordingly, Interview was held on 28th & 29th January,2022 at ASTC Tinsukia, and in pursuance of the list of selected candidates notified vide No. ASTC/HO/HIRING DRIVER/1997/2020/Pt.I/0477 dated, 1st February,2022, subject to termination of contract of engagement without notice or assigning any reason thereof, the following selected candidates in order of merit are hereby temporarily engaged in Assam State Transport Corporation as **Driver** on contractual basis for a period of 11(Eleven) months with a fixed monthly remuneration of Rs. 10,000/-(Rupees ten thousand) only per month plus daily allowance as admissible. The candidates are posted under the establishment of the Divisional Supdt., ASTC Tinsukia for operation of buses deployed for Oil India Ltd. Duliajan as contract services.
