ORDER Dated, Guwahati the 14 th February, 2022.

Whereas Assam State Transport Corporation has initiated and started new business with Oil India Ltd. Duliajan and LOA for deployment of 10 Nos. of Non A.C. buses for 5(Five) years on contract basis has been received. In view of urgent requirement of Helper-cum-Cleaner to operate the newly procured buses with Oil India Ltd. Duliajan, Employment Notice was published vide No. ASTC/HO/HIRING DRIVER/1997/2020/Pt.I/0428 dated.12th January,2022 through the Dainik Januarbhumi (Jorhat Edition) published on 13th January,2021.

Accordingly, Interview was held on 29th January,2022 at ASTC Tinsukia, and in pursuance of the list of selected candidates notified vide No. ASTC/HO/HIRING DRIVER/1997/2020/Pt.I/0478 dated, 1st February,2022, subject to termination of contract of engagement without notice or assigning any reason thereof, the following selected candidates in order of merit are hereby temporarily engaged in Assam State Transport Corporation as Helper-cum-Cleaner on contractual basis for a period of 11(Eleven) months with a fixed monthly remuneration of Rs. 8,500.00(Rupees eight thousand five hundred) only per month plus daily allowance as admissible. The candidates are posted under the establishment of the Divisional Supdt., ASTC Tinsukia for operation of buses deployed for Oil India Ltd. Duliajan as contract services.

Further, the above engagement will be on purely temporary basis and in no way related to the cadre strength of ASTC. The term of contract may be extended up to 5(five) years in the same terms and conditions on satisfactory performance.
